This project showcases 50 maximum security forensic beds designed to foster a secure environment conducive to rehabilitation and safety, underscoring the center's commitment to advancing standards in mental healthcare.

## Cabarrus County Regional Mental Health Treatment Center | Concord, NC | Principal Architect | 2026 | \$44.5M

This 60,000 SF Mental Health Treatment Center serves adults and pediatrics. Programs include Behavioral Health Urgent Care (separate units for adults and pediatrics), facility based crisis (pediatric), and residential treatment (pediatric).

### Mecklenburg County Facility Based Crisis Center | Charlotte, NC | Principal Architect | 2026 | \$17.9M

This project includes a 21,000 SF, Mental Health Treatment Center that provides services for adults in crisis. The center includes a Behavioral Health Urgent Care and an Acute Inpatient Unit.

In partnership with HKS, this 200-bed psychiatric hospital for adults, pediatrics, geriatrics and forensic populations includes crisis observation units, procedure suite, PHP/ IOP programs and outpatient support for adult and pediatric populations.

## UCLA Resnick Neuropsychiatric Replacement Hospital | Los Angeles, CA | Behavioral Health Consultant | 2025 | \$260M

In partnership with HOK, this 119-bed Academic Medical Center Psychiatric Hospital for adults, pediatrics, and geriatric populations is a challenging renovation in an existing building with low ceiling heights and an inefficient structural grid. Various innovative care solutions created a highly therapeutic and safe environment.

## Starmount Katie Blessing Center | Charlotte, NC | Behavioral Health Planner | 2026 | \$62M

This project entails the revitalization of a preexisting structure, spanning 38,500 GSF. Elevating its architectural narrative, it includes a two-story addition, an expansive outdoor behavioral health garden, and a state-of-the-art gymnasium. Orchestrating a seamless transition to a grandeur 72-bed inpatient behavioral health hospital, it adheres to the highest safety standards, signifying a commitment to functionality and compassion within the community.

# Galveston County Behavioral Health Center | LaMarque, TX | Behavioral Health Planner | 2024 | \$13M

In partnership with Huitt Zollars, hX led planning and design for a 12 patient extended observation unit and 12 resident crisis respite units for the County of Galveston. The project included the reuse of an existing 22,000 SF building with the addition of a new entry lobby.

In addition to increasing Inpatient capacity, the masterplan includes a campus-style recovery village that addresses identified gaps in the communities continuum of care and improving social determinants of health for its residents

In partnership with Perkins&Will, this 240,000 SF project includes a 264-bed Academic Medical Center Psychiatric Hospital with dedicated spaces for staff and student education and research and an off-unit therapy mall and dining facilities.

## Broughton Hospital Admissions Canopy and Maintenance Building, Morganton, NC | Principal Architect | 2023 | \$1.9M

hX collaborated with DHHS, SCO, and Broughton Hospital to design and document two new canopies, including a specialized canopy for infectious disease screening, as well as leading the design of a new Maintenance Building.
